## REPORT OF RESULT OF MEETING BY CHAIRPERSON:

TO,

THE NATIONAL COMPANY LAW TRIBUNAL, MUMBAI

I, Sushil Kumar Agrawal, the person appointed by the Hon'ble National Company Law Tribunal, Mumbai Bench, to act as chairperson of the meeting of equity shareholders of Ishwarshakti Holdings \& Traders Limited, summoned by notice served individually upon them and by advertisement dated the 30.11.2023, and held on the 06.01.2024 at Kilachand Conference Room, $2^{\text {nd }}$ Floor, IMC Building, IMC Marg, Churchgate, Mumbai - 400020, Maharashtra, do hereby report to this Hon'ble Tribunal as follows:

1) The said meeting was attended either personally or by proxy by 26 Shareholders of the said Company entitled together to $13,41,230$ Equity Shares, representing [ 93.13 percentage ] of the total value of the shares of the Company.

2) The draft Scheme of Arrangement was read out and explained by me to the meeting, and the question submitted to the said meeting was whether the Equity Shareholders of the said company agreed to the draft Scheme of Arrangement submitted to the meeting and agreed thereto.
3) All 26 (twenty six) equity shareholders representing $93.13 \%$ of the total shareholding and $100 \%$ of the shareholders, present and voting were of the opinion that the draft Scheme of Arrangement should be approved and agreed to. All 26 shareholders present at the court convened meeting held on $6^{\text {th }}$ January 2024 and voted in favour of the proposed Scheme of Arrangement. Table representing the details of the equity shareholder who voted at the said meeting is annexed as Annexure-"A".
4) The facility of voting through remote e-voting was provided to all the Shareholders pursuant to the provisions of Section 230 of the Companies Act, 2013 read with Rule 9 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016. Mr. Milan Mehta, Practising Company Secretary, Mumbai was appointed as the Scrutinizer for ascertaining the requisite majority for the votes cast through remote e-voting and voting at the meeting on the resolution as set out in the notice of meeting of the Shareholders convened by this Hon'ble Tribunal.
5) The Scrutinizer then submitted the consolidated report on the votes cast by the Shareholders through remote e-voting and voting conducted at the meeting.
6) 8 (eight) Shareholders (equity) representing $53.04 \%$ of the total equity shareholders of the company voted through E-voting.
7) All the Shareholders representing $76,38,900$ in value of the Shareholders voting through e-voting are of the opinion that the draft scheme of arrangement should be approved and agreed to. The summary of the result of the e-voting upon the said question was as follows:
